Multimodal Transportation Fund

PennDOT has begun accepting applications for the next round of funding grants under the Multimodal Transportation Fund. Applications are due by 4:00 on November 5, 2024. Grant recipients will be announced in 2025 for funding that will be available in July 2025.

PCCD Funding Availability Announced

2024-25 VIP and CCVI Funding:

The Pennsylvania Commission on Crime and Delinquency (PCCD) recently announced the availability of Violence Intervention and Prevention (VIP) and Collaborative Community Violence Intervention (CCVI) Strategies Grants. Counties are eligible applicants for each of these opportunities.

FY 2024 VIP Grants:

Approximately \$40-45 million in funding is available to support a wide range of intervention and response strategies designed to reduce community violence. Additional details can be found in the **funding announcement**. This solicitation is open through October 31, 2024, at 8:00 PM and requires submission of **specific materials** through **SurveyMonkey**.

FY 2024 CCVI Strategies Grants:

Approximately \$5-6 million in funding is available to support collaborative responses to community violence. Additional details can be found in the **funding announcement**. The deadline to apply is **October 31, 2024** and applications are made through **Egrants**.

<u>2024-25 Continuing County Adult Probation and Parole Funds</u> (formerly Grant-in-Aid)

The Pennsylvania Commission on Crime and Delinquency (PCCD) is now accepting applications for Continuing County Adult Probation and Parole Grant (CCAPPG) funds. A county that provides adult probation staff shall receive grant funding from the Commonwealth for costs incurred only to the extent that it meets the qualifications and standards established by the Commission.

Act 114 of 2019 established PCCD's responsibility to analyze data provided by counties in administration of this fund. Based on the data received, counties may see a change in their award from prior years. Each eligible county's FY2024-25 award and projections for three additional years is available within Appendix A of the **funding announcement**. The deadline to apply is **October 31, 2024** and applications are made through **Egrants**.

OOR Updates

The Office of Open Records has two important updates to share:

1) We have updated the **Standard Right-to-Know Law Request**Form. Among other changes, the form is now two pages and includes a required checkbox affirming that the provided name and contact information is accurate and that the requester is a legal resident of the U.S..

2)The policy for requesting OOR Records has been modified and can be reviewed **here**. Notably, requests to the OOR must be made on either the **OOR's Standard Right-to-Know Law Request Form** or by using the **OOR's Online Form**.
