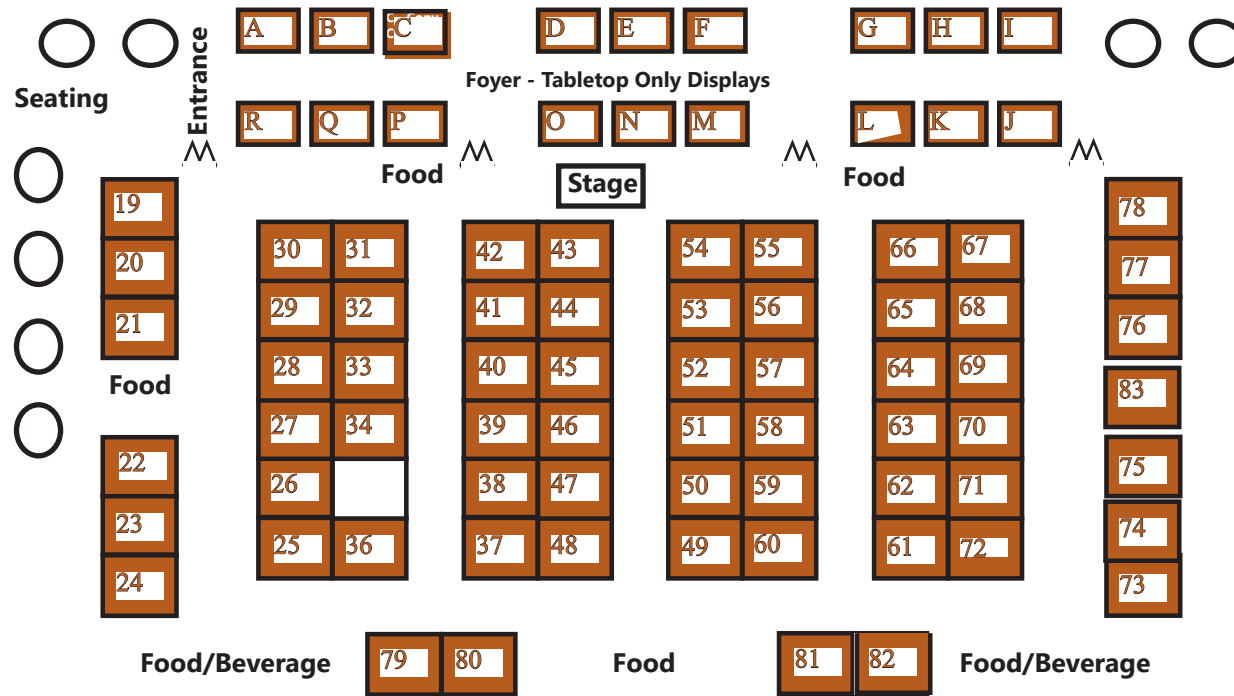


CCAP reserves the right to adjust the layout if deemed beneficial to exhibitors and attendees. Space is limited! There are 64 booths in the main hall that measure 8' deep by 8' wide and include one 6' skirted table, two chairs, a head sign and a wastebasket. There are also 18 tabletop only displays in the foyer that include one 6' skirted table, two chairs, a head sign and a wastebasket; there is no pipe-and-drape surrounding tabletop displays. The exhibit area has facility carpeting. Exhibitors may purchase additional furniture or alternate carpeting for an additional fee using the Exhibitor Service Request Form. Booth selection is on a first come, first paid basis.
