2016 CCAP Best Practice Award Nomination

The Chester County Youth Center (CCYC) proudly nominates our "Teddy Bear Drop" program for the County Commissioners Association of Pennsylvania Best Practice Award (CCAP). Every year, our center brainstorms ideas to solve the problem of how our residents can accomplish "meaningful" community service inside the walls of a detention center. Our Chester County Community has been so generous to our center with programs, collaborations, donations, etc. and we wanted a way to be able to pay it forward. How can this be done by youth who are detained?

Program coordinator, Carrie Avery, reached out to Chester County Hospital to see what needs they had with the focus being youth. Carrie was invited to speak at the Hospital Knitting Tea to a group of incredible hospital volunteers. These dedicated volunteers shared their beautiful craftsmanship of crocheted blankets, knit caps for infants and cancer patients, and hand sewn teddy bears for children in the hospital. Immediately, the thought of our Center and how we could contribute to the teddy bear donation which the volunteers had shared was dwindling because of the demand.

Our residents in our Detention Center and Shelter were extremely excited to begin this project. We purchased 100 animals that needed to be stuffed and sewn. In July, we began this project. Thinking this would take weeks, maybe even months to complete, our youth surprised us all by completing this daunting task in just 3 days. Both shelter and detention residents stuffed the variety of animals, and our shelter girls completed the project by sewing up the bellies.

Our "Teddy Bear Drop" project has helped to bring community service inside the walls of a detention center all while paying if forward to our Chester County Community. It is difficult for detention centers to be able to provide "meaningful" community service and this project has shown that we can achieve this goal which directly falls under the Balanced and Restorative Justice Accountability Goal. Our residents were awarded community service credit through our Juvenile Probation Department Community Service Program. Despite our current life situations, instilling a "pay it forward attitude" in youth is something we try to do daily here at CCYC. This project has truly achieved that goal. Our youth are constantly asking "when are we going to make teddy bears again?"

To date, we have completed two "Teddy Bear Drops," supplying over 200 bears to the Chester County Hospital; one on August 6th and the other on December 17th. On both dates, CCYC staff and Shelter Residents delivered the stuffed animals to the Hospital. Kathy Stocker, Director of Volunteer Services, was there to greet us at the front entrance of the hospital with a gracious heart. Kathy showed extreme gratitude to our shelter girls for the donation and explained where the animals would be going. This was a great life lesson for our youth to see a project through that they themselves had completed for other youth in need.
