Chester County Government Awarded Top Honor for Employee Well-Being



For the second consecutive year, the American Heart Association (AHA) awarded Chester County Government a Platinum recognition for "its commitment to employee health and well-being." The County achieved Platinum status – the highest – on the AHA's Workforce Well-Being Scorecard by scoring in the top eight percent of

492 participating organizations nationwide.

The AHA developed the *Workforce Well-Being Scorecard* in collaboration with industry experts to help employers build a science-backed, employee-centric culture of health and well-being.
