Dept. of Treasury Obligation FAQ

The U.S. Department of Treasury released **new FAQs** related to their **Obligation Interim Final Rule (IRF)** for the ARPA State and Local Fiscal Recovery Fund (SLFRF).

Of note, the **FAQs address the major concerns NACo voiced to Treasury concerning the Obligation IFR**, particularly around payroll, reclassification of funds and the obligation estimates.

Intermediate Punishment Treatment Program

The PCCD Office of Justice Programs has announced the availability of **\$17.7million in state funds to support Intermediate Punishment Treatment Programs**. The primary purpose of the grant program is to support restrictive conditions imposed as part of county probation.
