The County Commissioners Association of Pennsylvania (CCAP) is a nonprofit, nonpartisan organization representing county leaders statewide, including commissioners, council members, county executives, administrators, clerks, and solicitors across Pennsylvania's 67 counties. CCAP is the unifying voice of Pennsylvania counties that offers essential guidance and resources on legislation, education, media, insurance, technology, and other critical matters, ensuring the delivery of vital services to residents statewide.

## HOW IT ALL STARTED

**1886**



The first annual convention of counties was held, beginning as the Pennsylvania State Association of County Commissioners.

**1897**



The earliest written record of the organization dates to October 6, 1897, when Lancaster County Commissioner W.W. Griest attended the 11th annual Convention of the County and noted the first formal meeting of the Commissioners of Pennsylvania.

**1913**



The Governor approves the formation of an organization of county officials.

**1953**



On July 28, 1953, a Second Class County Code was enacted, specifically regulating second-class counties. Pennsylvania established nine county subgroupings for legislating and regulating county affairs, including two types of second-class counties.

**1955**



A County Code was applied to third through eighth-class counties.

**1960s**



The counties' human services role grows significantly and expands to include additional programs such as mental health, children and youth, behavioral health, and other related services.

**1969**



The Pennsylvania State Association of County Commissioners hired its first part-time staff to maintain a year-round presence in Harrisburg.

**1980**



The state legislature changed the unemployment law, and PSACC (CCAP) saw an opportunity to provide members with an invaluable service. The UC Trust was formed to represent counties at claim hearings.

**1993**



A workers' compensation program like PCoRP was established so that counties could have an alternative to the state fund (SWIF). PComp started operation with 12 counties on January 1, 1993, growing to 51 members and 15 county-related entities by 2022.

**1994**



The Pennsylvania State Association of County Commissioners becomes the County Commissioners Association of Pennsylvania (CCAP).

**1995-2008**



CCAP added additional insurance programs, including liability insurance, professional and general insurance, professional and general liability to nursing homes, a complete range of medical, dental, vision, and prescription plans, and a self-insured unemployment compensation program.

**2018**

Second class A counties are consolidated into the County Code, effective in December.

This brings us to the present day, where we remain steadfast in our commitment to providing unwavering guidance, continuous support, and exemplary leadership to uphold the highest standards in county government.

## GOVERNMENT RELATIONS

CCAP represents counties with a unifying voice in county government, fostering connections and providing crucial policy and legislative information. Through our professional government relations team, CCAP actively champions state-level policies to enhance county residents' well-being.

The Association works closely with the National Association of Counties (NACo) to strategically coordinate federal advocacy initiatives for maximum impact. Strengthening county governance by promoting flexibility and autonomy in governmental affairs through grassroots lobbying efforts, CCAP's efforts result in favorable legislation, programs, and policies, supporting county leaders in delivering essential services.

Additionally, CCAP educates the public, government partners, decision-makers, and the media about the role of the county government. Each year, counties review and affirm policy position statements to ensure CCAP provides a unifying voice of counties captured in the Pennsylvania County Platform.

CCAP's membership shapes and determines policies that address various county government issues and propose legislative priorities. CCAP's government relations staff then advocate for these priorities with the Administration, General Assembly, and Congressional leaders.



## COMMUNICATION

CCAP informs members of important news and happenings within the commonwealth through various resources. These include:

**Pennsylvania County News:** This quarterly publication addresses issues facing county and local governments and provides education and information essential to assisting counties.

**Legislative Bulletin:** Providing biweekly updates on the latest news in Harrisburg with relevant information on legislative bills, hearings, and events.

**CCAP Update:** A bi-weekly source for essential CCAP news and resources, including conferences, education, training opportunities, CCAP happenings, county updates, and government news.

**Insurance Matters:** A monthly e-newsletter on CCAP's insurance programs, training, and other important topics relevant to health and safety.

**Technology Services:** Conducts quarterly meetings and produces a newsletter addressing the latest in technology, policy, cybersecurity updates, and IT topics.

## MEDIA RELATIONS

CCAP promotes the efforts of counties through strategic communication at both the external and internal levels.

## EDUCATION

CCAP educates and engages members through conferences, workshops, training programs, and events annually. CCAP remains committed to collaborating with partners and developing diverse and affordable learning experiences.



### **The Academy for Excellence in County**

**Government** is a multiyear certificate training program for CCAP core members. CCAP and the Academy are committed to training informed and responsible public officials that ultimately provide Pennsylvania counties with the leadership needed to manage the complexities and challenges of today's county government.

### **The Center for Excellence in County Leadership**

**(CEL)** is a premier professional development program designed for CCAP core members who have completed one or more years of public service. The annual 2.5-day program is focused on fostering individual growth through interactive and immersive training, which improves participants' communication, decision-making, and leadership skills.

**GLIMPSE risk management workshops** are available each year in spring and fall. Topics include defensive driving, workers' compensation, human resources, communication, safety, KEYS (Keep Educating Your Staff), and much more. The workshops are offered at little or no cost to counties.



**LocalGovU** offers quality employee training online. Topics include risk management, corrections, health and wellness, human resources, law enforcement, safety, and management.

**Corporate Cost Control** offers unemployment compensation training through the UC Trust membership. This training is designed to help county employees understand topics of discipline, discharge, proper documentation, and hearing preparation, which are imperative to reducing claims costs.

CCAP's Technology Services hosts the **Annual Cybersecurity Summit** in collaboration with the commonwealth and Harrisburg University. This event brings together security experts and thought leaders from state and local government, federal agencies, education, and leading technology companies to share cyber incident prevention and response strategies.



# INSURANCE PROGRAMS

**CCAP's Insurance Programs** were created by counties for counties. Starting in 1980 with the CCAP UC Trust, counties directed CCAP staff to provide services, coverage, and training that the traditional market no longer offered. Tailored to the specific needs and risks of Pennsylvania counties, all CCAP's programs are owned and governed by the members they insure and include a wide variety of insurance solutions, such as:

**PComp** provides full statutory workers' compensation coverage to Pennsylvania counties and county-related entities, including in-house claims management, grant programs, risk management, and educational opportunities.

**PCoRP** is a unique combination of self-insurance, reinsurance, and risk management. Lines of coverage include property, crime, general liability, law enforcement, auto, public officials' liability, and cyber security liability. Members receive a full-service package, including in-house claims management, grant programs, risk management, and educational opportunities.

**COMCARE PRO** is a reciprocal risk retention group that provides stop-loss liability insurance for those counties implementing the behavioral managed healthcare program HealthChoices.





**Health Alliance** is a partnership between CCAP and the Delaware Valley Health Trust (DVHT), offering a complete range of medical, dental, vision, and prescription plans. Members enjoy guaranteed rates, low administrative costs, an incentive-based wellness program, COBRA administration, compliance assistance with the Affordable Care Act, and access to FSA, HRA, and HSA administrators.

**PELICAN** provides professional and general liability to nursing homes. Subscribers receive a full-service package, including in-house claims management, risk management, and educational opportunities.

**UC Trust** is a self-insured unemployment compensation program that provides member counties with a full-service package, including claims management, hearing representation, benefit charge auditing, educational opportunities, and a robust Employee Assistance Program.

**Tax Collector Bonds** provides surety bond coverage for tax collectors as required by state law.

**PACAH Bonds** (Pennsylvania Association of County Affiliated Homes) is a group bond program providing patient trust fund bonds for county-owned and affiliated nursing homes.

The **Volunteers** program provides insurance coverage for county volunteers. Coverage also extends to court-referred alternative sentencing, work release and juveniles participating under the Juvenile Tobacco Enforcement Program.

## FINANCIAL SOLUTIONS

CCAP also endorses a select group of organizations to provide financial solutions to counties.

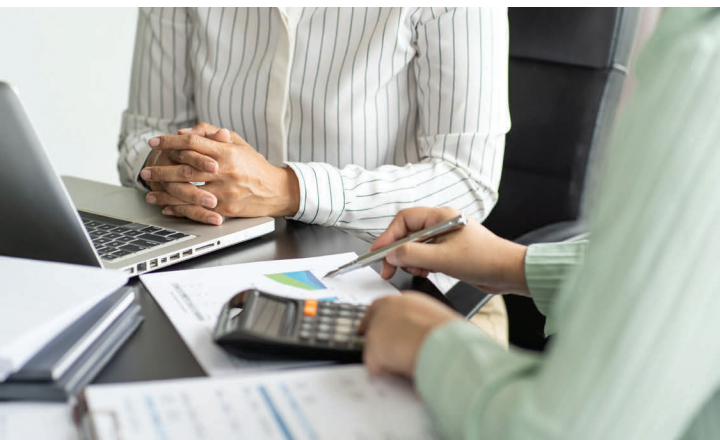
**Prison Inmate Medical Cost Containment (PIMCC)** provides medical cost management and education to assist county prisons with the containment of costs related to inmate medical expenses.

**Pennsylvania Local Government Investment Trust (PLGIT)** is a money market investment fund for counties, schools and municipalities. It also provides other investment and borrowing options.

**NACo/Nationwide Retirement Solutions** helps ensure the financial security of county employees with a competitive deferred compensation program and allows county employees many options for tax deferred supplemental retirement savings.

**NACo Live Healthy Dental and Health Discount Program** provides relief to all county residents facing rising prescription, health and dental costs. The program is free to NACo member counties.

**cashVest<sup>®</sup> by three+one<sup>®</sup>** brings operational efficiencies to liquidity management for public finance officers, bringing peace of mind while ensuring maximum value on public funds.



## TECHNOLOGY SERVICES

CCAP Technology Services offer access to many resources and provide responsive, high-quality, innovative, and cost-effective technology services and solutions through leadership, collaboration, innovation, and a transformative approach.

**The Technology Core Program** advocates for county technology needs by collaborating with local, state, and federal partners and organizations. Our team provides timely and crucial cybersecurity information, IT Quarterly Meetings, a technology document and template library, website assessments, onsite IT assessments, IT security assessments, technology training and webinars, and cybersecurity awareness services to counties as a benefit of your CCAP membership.

**Enterprise Agreements** are statewide agreements that meet the needs of the counties and their affiliated local government entities providing discounted pricing models, including Microsoft, CrowdStrike, Sentinel One, Rubrik and Adobe.
