Election Funding Available for Counties

The Election Integrity Grant Program (EIGP) will provide funding to support the work of county governments and their election offices.

Individual funding will be based on the number of registered voters within the county in the previous primary election.

For additional information on county funding allocations, reference the EIGP County Allocation. County election officials must apply for EIGP grants between August 1-15, 2024.

Digital Equity Competitive Grant Program

The National Telecommunications and Information Administration (NTIA) recently announced the launch of the **Digital Equity Competitive Grant Program.**

This program supports initiatives to provide all communities with access and skills needed to participate fully in the digital world, regardless of background or circumstances. It complements digital equity efforts funded by the Capacity Grant Program.

Funding Announcement from PCCD

The Office of Victims' Services of the Pennsylvania Commission on Crime and Delinquency (PCCD) has announced the availability of funding for Rights and Services Act (RASA)/Victims of Juvenile Offenders (VOJO) 2025-2026. The goal this funding is to ensure that victims of crimes whose cases are processed within the criminal and juvenile justice systems receive all rights, notifications, and services to

which they are entitled under the law.

These funds are available to all 67 counites as a non-competitive grant. Each county's Year 1 allocation can be found in the **funding announcement**. Year 2 funding will be determined at the Victims Services Advisory Committee meeting in November 2024. Applications are due **Friday September 27, 2024**.

You must be registered with PCCD to access the Egrants System. If you are not registered, go to the website **egrants.pccd.pa.gov** and select Register.

Chester County Earns National Recognition



Chester County's Department of Computing and Information Services (DCIS) was recently recognized by the National Association of

Counties (NACo) for its Chester County GIS Productivity Tools and Applications project.

DCIS developed a series of GIS – Geographic Information Systems – tools for use by staff across County Government departments that not only increase productivity, but reduce, and in some instances, eliminate unnecessary costs.

NACo and The Center for Digital Government also recognized Chester County for maintaining its top-ten digital ranking for counties with populations between 500,000 and 999,999.

In reviewing Chester County's efforts to improve its digital, citizen and government experience through technology and leadership, the judges noted DCIS' upskilling of existing staff, providing new opportunities for innovation, and work with all County departments to identify challenges where tech solutions can help.

In a joint statement, Chester County Commissioners Josh Maxwell, Marian Moskowitz, and Eric Roe said, "As part of their service to county residents and their fellow employees, staff in DCIS continually look at ways to increase productivity, enhance digital services and technology, and optimize taxpayer dollars. Their use of tools and applications that track progress and performance, and their focus on ways that new technologies like AI and cybersecurity monitoring can innovate and improve services, deserve the recognition they have received. We congratulate them!"
